Article 1

**OBJECTIVE OF COOPERATION**

The objective of this Memorandum of Understanding (MOU) is to cooperate with each other in educational projects in areas of mutual interest

Article 2

**SCOPE OF COOPERATION**

The Parties agree to implement cooperative programmes including but not limited to:

- a. Exchange of best practices.
- b. Engagement of faculties and students in your projects/research works/field based studies or any welfare based programmes
- c. Skill based certification / add on certification courses.
- d. Organizing seminars / webinars / conferences / symposia, etc.
- e. Access of venue of both institutions to quality enhancement programmes organized at both the institutions as and when possible and mutually agreed upon.
- f. Undertaking Joint Research Programmes when and where possible.

Article 3

**FINANCIAL ARRANGEMENT**

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

Article 4

**LOCATION OF ACTIVITIES**

The Parties agree to implement the programmes stated in Article 2 at Khudiram Bose Central College and Society for Direct Initiative for Social and Health Action (DISHA)

1. Any changes in the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

**MODE OF CONDUCTING THE PROGRAMMES**

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the Online mode if required.

Article 6

**DURATION AND TERMINATION**

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 7

**INTELLECTUAL PROPERTY**

Each Party agrees to respect the rights to intellectual property of the other. Thus, any material published in any form by a Party or any information acquired from a Party, if utilized by the other Party, finding expression in any kind of publication by the latter shall be accompanied by the usual statement of source and attribution of credit. This clause shall continue to operate even after the present MOU comes to an end.

Article 8

**SENSITIVITY OF INFORMATION**

The parties undertake to respect the sensitivity of information pertaining to each other or acquired during collaborative work, for example among any community, and shall consult with each other before publicly sharing such information and will do so only after mutual agreement.

Article 9

**AMENDMENT**

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.
