- 3. To promote research/ continuing education activities between the institutes.
- 4. To collaborate in organizing Seminars, Workshops, and Conferences (both in online and offline mode). The host will provide all the logistic support in case of offline workshop and conferences.
- 5. Other activities as mutually agreed.
- 6. No financial liability on each side.

#### **Terms and Conditions**

- 1. Initially the MOU will be effective for five year but may be extended if mutually agreed be both the institutes.
- 2. This MOU may be amended, renewed or terminated by mutual written agreement of the institutes at any time.
- 3. Either institute shall have the right to terminate this MOU upon 60 days prior written notice to the other institute.
- 4. Nothing contained in this MOU shall inter or create for either of the institutes, any right over the intellectual or physical property of the other institute.

#### Coordinators

Both institutes will designate who will have responsibility for co-ordination and implementation of this agreement.
