## Memorandum of Understanding

This agreement is made on this .... 20 day of March, 2025

between

Khudiram Bose Central College, 71/2A, Bidhan Sarani, Kolkata – 700006, West Bengal

and

Oriental Media Forum, 112/1, Park Street, Kolkata - 700017, West Bengal

hereinafter individually referred to as the Party and jointly referred to as the Parties.

Both Parties having agreed that this MOU will be mutually beneficial for the Institutions for research collaborations, faculty improvement programmes and other academic activities and pursuant to the prevailing laws and regulations, policies and procedures of India have reached the following understanding –

# Article 1 - Objective of Cooperation

 a. The objective of this Memorandum of Understanding (MOU) is to cooperate with each other in educational projects in areas of mutual interest.

## Article 2 - Scope of Cooperation

The Parties agree to implement cooperative programmes including but not limited to:

- a. Exchange of best practices
- b. Skill based certification/add on certification courses
- c. Organising seminars/webinars/conferences/symposia, etc
- d. Faculty/ Expert and student exchanges
- e. Access of students to quality enhancement programmes organised at both institutions
- f. Undertaking Joint research programmes where possible

## Article 3 - Financial Arrangement

 a. Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

### Article 4 - Location of Activities

- The Parties agree to implement the programmes stated in Article 2 at Khudiram Bose Central College and Oriental Media Forum
- Any change of the location of the programme shall be mutually agreed upon by both the Parties

## Article 5 - Mode of Conducting the Programmes

 The programmes will be conducted primarily in offline mode. Necessary arrangements shall also be made to conduct programmes online, if required

#### Article 6 - Duration and Termination

- a. This MOU shall come into effect from the date of signing
- b. This MOU shall be in force for a period of five (5) years and may be extended for another period of five (5) years by mutual written consent from the Parties
- c. Either Party can terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of termination
- d. The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination

## Article 7 - Amendment

- This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall become an integral part of this MOU
- Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties
